**A. Mandate of the Unit**

Identify criteria offences and make timely ViCLAS booklet submissions to the Provincial ViCLAS Centre in compliance with Ontario Regulation 550/96.

**B. Executive Summary**

For the reporting year of January 1, 2010 to December 31, 2010 a total of fifty-one (51) ViCLAS booklets were submitted to the Provincial ViCLAS Centre for analysis. Forty-seven (47) sexual assault booklets were submitted along with one (1) for child luring and two (2) in relation to child pornography. There was also one (1) non-criteria submission, for criminal harassment.

During this period, seventy-two (72) Criteria Offences were identified and reported by the ViCLAS Coordinator. Of the seventy-two offences, sixty-nine (69) were for sexual assault; however, twenty-two (22) sexual assaults were classified as unfounded.

Statistically, the number of reported Criteria Offences and the number of submitted booklets decreased from previous years. In 2008, there were eighty-six (86) Criteria Offences identified and fifty-nine (59) booklets submitted. In 2009, there were ninety-six (96) Criteria Offences reported and seventy-two booklets (72) submitted for analysis.

**E. Anticipated Issues for the Future**

Electronic filing of ViCLAS submissions has been introduced to several Ontario police agencies on a trial basis. It is expected that all Services will be converted once the electronic program has been perfected and the new process has been established.
